

# The Story of the Old Testament

### **Course Description:**

This course is a three credit-hour survey of the Old Testament. Special attention will be given to the flow of God's interaction with the nation of Israel through the Old Testament era. Appropriate historical and cultural backgrounds will be addressed when introducing the thirty-nine books of the Old Testament canon. Major theological doctrines and high-profile characters of the Old Testament will be studied within their historical context.

#### **Course Objectives:**

- 1. Information: Students will gain a foundational knowledge of the content and historical context of the books of the Old Testament.
- 2. Exploration: Students will critically evaluate the impact of Old Testament characters on their Christian worldview, with applications to their own lives.
- 3. Transformation: Students will learn to apply the foundational teachings of the Old Testament to a life of discipleship and living the ways of Jesus.

### **Christian Worldview & Teaching Philosophy:**

This course is an Oklahoma Christian University Bible course offered for credit at the Northwest School of Discipleship (NWSD), based in Tigard, Oregon. NWSD is a church-based educational initiative that seeks to help transform believers into the image of Christ through offering courses grounded in the three essential features of discipleship: Knowledge, Affection, Obedience.

### **Course Requirements:**

### 1. Quizzes (30%):

Expect a quiz or exam class meetings as outlined in the course schedule. Quizzes will be given over readings in <a href="Encountering the Old Testament">Encountering the Old Testament</a>, readings in the Bible, and memory work as assigned in the class schedule. Quizzes may use true-false, multiple choice, matching, fill-in-the-blank, short answer, or paragraph essay questions. A student is permitted one excused absence for the term. Excused absences are for illness or family emergencies and require securing approval from the instructor PRIOR to the class missed. Quizzes will NOT be made up, but students with one excused absence will not have their one "zero" score averaged into their quiz grade. Unexcused absences receive zero credit for their quiz grade for the day.

### 2. Class Participation (5%):

Students are expected to actively participate in discussions, debates, and other class activities. Excellent participation requires near-perfect attendance, a demonstrated knowledge of assigned readings, and active oral engagement in class discussion.

#### 3. Reflective Essays (25%):

Three **required** reflective essays will be written, worth a total of 25% of the total course grade. A reflective essay is NOT a research paper, but rather personal reflections on your reading and thinking about the biblical text. Each essay should be 800 words or more in length and must be written in your own words. The essay will be graded on content, appropriate engagement of the biblical text, clarity of reasoning, and adherence to the standards of formal writing and proper English grammar. Subject matter for each essay and further instructions on this assignment will be addressed in a handout on the first day of class. Failure to turn in one or more reflective essays will result in a failing grade in the class, no matter how many points the student has in other areas of class work (exams, quizzes, and class participation). Essays are due at the beginning of class on the day assigned. Late assignments will be penalized 10% per day.

### 4. Exams (40%):

There are two major exams in the course: A Mid-Term and a Final. Each exam is worth 20% of the total course grade. The exams may include objective questions (true-false and multiple choice), fill in the blank statements, short answer, matching, and essay questions. The exams may cover material from class discussions, your assigned readings, and required memory work.

Plagiarism also includes passing off another person's work as one's own. Plagiarism undermines the ethics of the academy and the specific Christian purposes of Oklahoma Christian University. Plagiarism is one form of academic dishonesty. Plagiarism triggers the following consequences.

### Consequences for Academic Dishonesty

- 1. First offense: the mandatory consequence for academic dishonesty with regard to an examination or assignment is zero (0) credit. Faculty have discretion to assign appropriate consequences for academic dishonesty other than on examinations or assignments. Faculty must send documentation of the first offense to the appropriate chair, the dean of the appropriate college, the CAO, and the Dean of Students.
- 2. Second offense: the mandatory consequence for a second incident of academic dishonesty, in the same course, during the same term, is a failing grade (F) in the course. Faculty shall provide documentation of the second offense to the appropriate academic leader, dean, CAO, and the Dean of Students.
- 3. Appeal: A student accused of academic dishonesty may appeal the determination using the process for Grade Appeals, found below.
- 4. Multiple Course Violations: When a student has been academically dishonest in more than one (1) course the Academic Appeals Committee may assign consequences up to and including suspension from the University. The Academic Appeals Committee will inform the CAO and the Dean of Students in writing of consequences imposed and will report annually on its activities to the University's Academic Affairs Committee. 5.

### Americans with Disabilities Act


